



# Privacy Policy

Protecting your private information is our priority. This Statement of Privacy applies to fundingpips.com, and governs data collection and usage.

Funding Pips website is an eCommerce site. By using Funding Pips website, you consent to the data practices described in this Statement and all extensions and addendums to this Statement.

## **Collection of your Personal Information**

In order to better provide you with products and services offered, Funding Pips may collect personally identifiable information, such as your:

- First and Last Name
- Home Address
- Mailing Address
- E-mail Address
- Phone Number
- Financial Information

If you purchase Funding Pips products and services, we collect billing and credit card information. This information is used to complete the purchase transaction or issue payments to you. We do not collect any personal information about you unless you voluntarily provide it to us. However, you may be required to provide certain personal information to us when you elect to use certain products or services. ## **Use of your Personal Information**

## **Sharing Information with Third Parties**

Funding Pips may sell, rent, or lease customer information to third parties for the following reasons: We will collect this data and provide it to third parties if it is a necessary step in the User account creation process, contributes to the ease of use, reliability, or functionality of our products, or if it is of mutual interest to Funding Pips. Funding Pips may, from time to time, contact you on behalf of external business partners about a particular offering that may be of interest to you. In those cases, your unique personally identifiable information (e-mail, name, address, telephone number) is transferred to the third party. ## **Tracking User Behavior**

## **Automatically Collected Information**

Information about your computer hardware and software may be automatically collected by Funding Pips. This information can include your IP address, browser type, domain names, access times, and referring website addresses. This information is used for the operation of Page 3 of 5 services, to maintain the quality of the service, and to provide general statistics regarding the use of the Funding Pips website.

## **Use of Cookies**

Funding Pips website may use cookies to help you personalize your online experience. A cookie is a text file that is placed on your hard disk by a web page server. Cookies cannot be used to run programs or deliver viruses to your computer. Cookies are uniquely assigned to you and can only be read by a web server in the domain that issued the cookie to you. One of the primary purposes of cookies is to provide a convenience feature to save you time. The purpose of a cookie is to tell the Web server that you have returned to a specific page. For example, if you personalize Funding Pips pages, or register with Funding Pips site or services, a cookie helps Funding Pips to recall your specific information on subsequent visits. This simplifies the process of recording your personal information, such as billing addresses, shipping addresses, and so on.
